

## Project of the Year Award

**NMPP Energy Project of the Year Awards** are given to an energy/utility related project implemented within the last three years for the overall benefit of the community. Projects are judged on the benefits created for the betterment of the elected or administrative offices, utility-related employees or customers of the utility.

**Eligibility:** All communities that are a member or participant with one of the NMPP Energy organizations (ACE, MEAN, NPGA, NMPP) are eligible to nominate and receive the award.

**Award:** Award recipients will be recognized at the NMPP Energy Annual Conference on Wednesday, March 19, 2025. **An award of \$200 will be given to the local utility or a local project for their use.**

**Judging:** Award winners will be selected using the criteria suggestions below.

Examples of previous winning projects include:

- A project that promotes public power or public gas.
- City employees or elected officials involved in the creation or implementation of the project.
- Collaboration among multiple departments/groups e.g. other utilities, parks, etc.
- Multi-community organization participation
- Arranging or providing employee training on a regional basis.
- Cost savings for the utility or customers – new/improved programs or methods that save manpower, space, materials, equipment or other cost items.
- Job creation or retention in community.
- Creation of energy-efficiency practices.
- Environmental stewardship, e.g. paperless office, tree planting, reducing air/water emissions.
- Customer service Initiatives (amending policies to meet the needs of customers).
- Customer communications – creative bill “stuffers”, innovative strategies to communicate policies & information.
- Energy education, energy audits
- Downtown streetscapes
- Façade upgrades/downtown redevelopment
- Utility upgrades and rebuilds
- Project using new technology or unusual utilization of an old technology
- Creative marketing or educational campaign
- Youth participation
- Demonstration of exceptional safety performance or homeland/cyber security
- Public space project
- City Auditorium Renovation
